**Ashrita Prasad Kotha**  
**Jindal Global Law School India**

Ashrita Prasad Kotha is Assistant Professor and Assistant Director, Centre for Comparative and International Taxation at Jindal Global Law School, India. Ashrita has taught undergraduate courses on Taxation Laws, Property Law, Law of Contracts and Alternate Dispute Resolution. She was the faculty co-ordinator for the Jindal Oxford Summer School between 2015 and 2017. She convenes a Taxation Law Reading and Discussion Group every alternate term to discuss contemporary topics of taxation law and policy.

She has been working extensively on cess taxes and has presented her research at the Eighth History of Tax Law Conference at University of Cambridge, and at the National Institute for Public Finance and Policy and Centre for Budget Governance and Accountability. She has been a non-resident expert with Vidhi Centre for Legal Policy. She has completed her BCL from University of Oxford as a KC Mahindra Scholar. **University of Oregon, USA**

Roberta Mann teaches and writes about tax law, with a particular emphasis on how the tax system affects the environment. Professor Mann served as the only tax lawyer on the National Academies of Science committee studying the greenhouse gas impact of the Internal Revenue Code. She is active with the ABA Tax Section, the National Tax Association, and the Portland Tax Forum, and regularly speaks at the annual Global Conference on Environmental Taxation. Before beginning her teaching career, Professor Mann served on the staff of the Joint Committee on Taxation and worked for the Office of Chief Counsel of the Internal Revenue Service in Washington, D.C. Mann earned her LLM in Taxation with distinction from Georgetown University Law Center and her J.D. cum laude from the Arizona State University College of Law. Mann also holds an M.B.A. from Arizona State University. Scholarly work includes, "Controlling the Environmental Costs of Obesity," 47 Environmental Law (2017) (symposium). **Indrajit Dube**  
**Indian Institute of Technology, India**

Dr Indrajit Dube is Associate Professor at Rajiv Gandhi School of Intellectual Property Law, Indian Institute of Technology, Kharagpur. He has worked as a practitioner, legal executive, and academician. His areas of interest include Corporate Laws, Corporate Governance and Corporate Environmental Governance. He has been teaching these and allied courses in undergraduate and post graduate levels for more than fifteen years in different Universities, National Law Schools and Management Schools. Dube has numerous publications in refereed journals published from India and abroad. His writings are mainly focused on Independent Directors, Directors Liability, Integrated Reporting, Corporate Social Responsibility, Corporate Governance in the Energy Sector, Environmental Governance etc. He has several books to his credit. His book on Corporate Governance published by Lexis Nexis Butterworths is widely referred in National and International Institutes of eminence.

### **Professor Annet Wanyana Oguttu**

Annet Wanyana Oguttu is a professor of tax law at the University of South Africa. She holds a Doctorate in tax law, a Masters in tax law, LLB degree, HDip International Tax Law and a Diploma in Legal Practice. She has published many articles on international tax law topics in internationally accredited journals and is a rated researcher under South Africa's National Research Foundation. She is the author of "International Tax Law: Offshore Tax Avoidance in South Africa" (Juta, 2015) and a co-author of "Tax Law: An Introduction" (Juta, 2013). In 2014 the President of South Africa appointed her as one of the Commissioners of the South African Law Reform Commission. In 2013, South Africa's Minister of Finance appointed her as a member of the Davis Tax Committee to assess South Africa's tax policy framework - she chairs the BEPS Subcommittee. In 2012, the UN/DESA enlisted her as a member of the "Expert Group to Develop a UN Course on Double Tax Treaties" and in 2015 the UNECA also enlisted her to write the South African report on "Domestic Revenue Mobilisation in Africa". She has been a visiting professor - lecturing international tax law and tax treaties at the University of Pretoria, the University of Johannesburg, at the African Tax Institute and at the Academy of Public Finance (Vienna University of Economic and Business in Austria). She is the Board President of the South African Institute of Tax Practitioners; a Board member of the South African Fiscal Association and of the African Tax Research Network - based at the African Tax Administration Forum. Annet is awarded the 2017 Abe Greenbaum Fellowship and will be working with Dr Ann Kayis-Kumar.

### **Professor Duoqi Xu**

Duoqi Xu is Professor of Law, at Shanghai Jiao Tong University KoGuan Law School, is Dawn Scholar of Shanghai, and was one of Ten Young Jurists of Shanghai in 2012. Professor Xu was a Fulbright visiting scholar at Harvard Law school from August 2016 to July 2017, and was a visiting scholar of Hauser Global Program at New York University from August 2008 to September 2009, a visiting scholar at Duke University 2013 and a visiting professor of Taiwan University in 2013. Professor Xu is the executive director of the Financial Law and Policy Centre and the founder and chief editor of the Journal of Internet Finance and Law. Professor Xu is the executive vice-chairperson of the Tax Law Research Association of Shanghai Law Society, the vice-chairperson of the Financial Law Research Association of Shanghai. She is also a mediator at the Shanghai International Economic and Trade Arbitration Commission, and an arbitrator at the Guangzhou Finance Arbitration Commission and Zhuhai (Hengqin) Finance Arbitration Commission. Duoqi is awarded the John Raneri Fellowship and will be working with Professor John Taylor.

### **Dr Jennifer L. L. Gant**

Jennifer Gant is an undergraduate (LLB) lecturer in contract law, commercial law, and jurisprudence; LLM module leader and lecturer in a number of insolvency related subjects; and course leader for a distance learning LLM course in legal practice. She is also a non-practising employment law solicitor of the United Kingdom and Wales and holds an MBA, an LLM in Insolvency and Employment Law, and has qualifications in French and Italian. ### **Professor Lynn Hodgkinson**

Lynn Hodgkinson is Professor of Accounting and Finance at Bangor Business School at the University of Wales, UK. Timothy Todd is an Assistant Professor of Law at the Liberty University School of Law, Virginia, USA and holds a Juris Doctor (summa cum laude). He has also served as a member of the INSOL Europe Joint Academic-Practitioner Project on Cooperation and Communications, the Academic Advisory Group on the INSOL International Diploma Project and is now a member of the Course Committee of the INSOL International Global Insolvency Practice Course. During his time with us Paul collaborated with Dr Jenny Buchan and Associate Professor Anil Hargovan to deliver a

Thought Leadership lecture on the insolvency law topic "Value Preservation for One or for All: The Balance between Contract Disclaimer and Effective Rescue". They discussed the disclaimer right of liquidators, both in the context of the appeal from *Re Willmott Forests Ltd* [2012] VSCA 202 that was heard in the High Court of Australia on 9 August 2013, and as the rule applies in the specific context of franchisor insolvency. The lecture was arranged with the kind concurrence of the Insolvency Practitioners' Association and of the Sydney law firm Henry Davis York, at whose premises the lecture took place.
