BlackRock Research Award

AUD\$10,000 will be awarded to the best paper presented on Capital Markets/ Funds Management/ Mutual Funds.

BankScope Prize

AUD\$2,500 will be awarded for the best paper in Banking. Authors whose institutions subscribe to BankScope data are eligible.

Zephyr Prize

AUD\$2,500 will be awarded for the best Corporate Finance paper. To be eligible for the award the university you attend will have to subscribe to the global M&A deal database, Zephyr by Bureau van Dijk.

Sirca Research Prize

AUD\$2,500 for the best paper which has used SIRCA Data. Use of SIRCA data must be acknowledged in the paper.

Australian Securities Exchange Prize

Awarded to the best paper presented on derivatives/ quantitative finance.
