### Procedure for approval of courses for transfer of credit

The following information is for students who are enrolled at UNSW and wish to participate in overseas exchange programs.

The international exchange director is [Dr Jason Zein](#), Australian School of Business Building, Room 310.

All students need to have prior approval of courses before going on exchange. If the approved courses are not available once you are at the overseas university, you need to email [Dr Jason Zein](#) with the new course details to gain approval. Approval for finance courses will not be granted after you have completed your international exchange program and returned to Australia.

**Please note:** the following core Finance courses cannot be completed overseas:

- FINS1612 Capital Markets and Institutions
- FINS1613 Business Finance
- FINS2624 Portfolio Management
- FINS3616 International Business Finance
- For students considering fourth year Honours, FINS3775 Research Methods in Finance 1 cannot be completed overseas

### Steps for applying for transfer of credit

1. Students need to complete a separate transfer of credit form for Banking and Finance courses that you intend to undertake overseas

**Please note:** courses from other Schools should not be listed on the form.

2. Obtain details of courses for transfer of credit between UNSW and international universities
3. Fill in the form
4. Leave the form at the School office level 3, West Wing, Australian School of Business for approval by Dr Jason Zein and pick it up after 48 hours
5. If you need to speak with Jason Zein, please come to room ASB 310, or email [Dr Jason Zein](#) to make an appointment
6. If the university you wish to attend is not on the list or the courses you want to apply for credit for are not listed, please see Jason Zein

## International exchange information

### Information for overseas students wishing to study at UNSW

The following information is for students who are enrolled at universities overseas that participate in the UNSW Study Abroad and International Exchange Programs and who wish to undertake courses at Banking and Finance at UNSW.

#### Procedure for Application

All formal applications must be made through the Study Abroad Office or the International Exchange Program office at UNSW, depending on whether a prospective student is coming to UNSW as a Study Abroad student or an International Exchange student.

#### Course Structure and Subject Approval

The first two courses in Banking and Finance for a Major/Double Major in Finance are FINS1612 Capital Markets and Institutions and FINS1613 Business Finance. You must have taken and passed the equivalent of these two courses before you can proceed to the other courses. For example, FINS2624 Portfolio Management requires FINS1613 as prerequisite.

Most corporate finance courses would require FINS1613 as a prerequisite while all investment management courses require FINS2624 as either a core-requisite (FINS2624 taken concurrently) or prerequisite (must have completed the equivalent of FINS2624).
